### News from the Field

**California**: A diverse group of 30 stakeholders in the new **FireScape Mendocino** landscape gathered for their **first planning workshop** last month. A brief summary is in the attached *Notes from the Field*.

Georgia: A new landscape project was launched in the Southern Blue Ridge FLN with a workshop in Blairsville last week. The Georgia Blue Ridge Landscape encompasses much of the Blue Ridge in Georgia west of the existing landscape in the Warwoman/Tallulah Gorge area, and includes the Fire Adapted Communities Learning Network hub community of Towns County. The day-long workshop attracted a diverse group of 48 people from a wide variety of agencies, organizations and interest groups; landscape leads made the case for initiating the project, then solicited ideas for goals, constraints, focal areas and research needs. A smaller follow-up meeting will take place in late January or early February to refine these lists and begin an action plan. Missouri: Daniel Godwin recently received the Edward Komarek Graduate Student Excellence

Award from the Association of Fire Ecology. Among the items cited for his selection for this national award were his leadership in the University of Missouri Student Association for Fire Ecology chapter, including his work participating in—and promoting among fellow students—FLN prescribed fire training exchanges.

New Mexico: The prescribed fire training exchange in Black Lake this fall was intended to build local capacity and support for prescribed fire. Eytan Krasilovsky (<a href="mailto:eytan@forestguild.org">eytan@forestguild.org</a>) reports that four Rocky Mountain Youth Corps members who took part in the exchange are leading prescribed pile burning this month on ten acres of private lands in Taos Canyon under a partnership between Taos County and the Taos Soil and Water Conservation District.

Eytan also reports a **good response at a community meeting** last weekend to a presentation he gave on treatments that will be conducted in the coming year under **Scaling-up to Promote Ecosystem Resiliency** (SPER). Motivated by the nearby Tres Lagunas Fire last summer, landowners have already begin submitting applications to be a part of this work.

# Opportunity for Input: NPS Wildland Fire Strategic Plan

**NPS Plan**: The **National Park Service** is inviting those who "live, work, or play in an area which has the potential to be affected by wildland fire activity" to **comment on** its 12-page <u>2014-2019 Wildland Fire Strategic Plan</u>. The comment period closes **January 15**.

# Articles & Reports: Great Basin Fire Effects / Fire Severity

Great Basin Fire Effects: The Forest Service has published a general technical report, "A Review of Fire Effects on Vegetation and Soils in the Great Basin Regions: Response and Ecological Site Characteristics." The report—covering semi-arid systems in the central and northern Great Basin and Range, Columbia River Basin and Snake River Plain—summarizes available literature on topics that include effects on individual species and communities, invasive species, surrogate treatments, etc.

**Fire Severity**: In "Unsupported Inferences of High-Severity Fire in Historical Dry Forests of the Western United States: Response to Williams and Baker," a <u>correspondence item</u> in *Global Ecology and Biogeography*, Peter Fulé and 17 co-authors **take issue with the conclusions** drawn by **Williams and Baker (2012)** in "Spatially Extensive Reconstructions Show Variable-Severity Fire and Heterogeneous Structure in Historical Western United States Dry Forests." Fulé et al. assert that "conservation of dry forest ecosystems in the western United States ... is not consistent with a present-day disturbance regime of large, high-severity fires, especially under changing climate."

# Maps: WUI Development / Forest Service App

WUI Development: <u>Headwaters Economics</u> has an interesting **interactive map** of WUI development in the West, on a county basis. Counties are coded based on **percentage of the WUI** that is still **undeveloped**, highlighting places where **land-use policy** changes may have the greatest effect on **managing costs** of wildfire.

Forest Service App: According to a recent <a href="news-release">news-release</a>, a variety of maps are now available for Android and iOS mobile devices. Maps are available through a free app, with individual maps ranging from free (e.g. motor vehicle use maps) to a few dollars (forest visitor maps). About 700 maps are available now, and interactive maps are in the works. The release notes that these should be useful to wildland firefighters as well as for public use.

Assistant Professor (Extension): This position is being established to connect the College of Forestry at Oregon State with collaboratives and community-based groups. The incumbent will work with federal agencies like the Forest Service and BLM; NGOs like Sustainable Northwest and The Nature Conservancy; state agencies; and the myriad collaborative natural resource management groups operating around the state and region. # FireScape Mendocino Workshop 1

November 2013

In early November, 30 people gathered to initiate a stakeholder-based approach to fire management of the Mendocino National Forest and, to the extent that neighboring landowners are interested, to the surrounding area. The group brought diverse backgrounds to the table—and to the field, as they visited the forest together—as well as enthusiasm for diving in to the work.

Fire Learning Network staff will help facilitate the early stages for this "all lands approach," using a planning methodology outlined in the Open Standards for the Practice of Conservation. This first workshop was designed to guide the group to conceptualize the scope, vision and conservation targets for its work, which will bring focus to the emerging collaboration. After two days of drawing on maps, brainstorming and peer assists, six sets of draft scope maps, vision statements and targets had been produced. The landscape's core team will follow this up by consolidating the perspectives of

all the participants into a single draft scope map and vision statement, as well as five to seven targets for the group's consideration at the next workshop.
