## News from the Field

**California:** The [four-minute video](#) “**Fall Burning in Orleans 2013**” was filmed by **Stormy Staats** and **Larry Luckham** during last fall’s **prescribed fire training exchange** hosted by the **FLN** and **Northern California Prescribed Fire Council**. It highlights a burn near Orleans, a **Fire Adapted Communities Learning Network** pilot community, featuring **interviews** with landowner **John Martin**.

**California:** **FireScape Mendocino** held its **second workshop** last month. The field trip highlighted the challenges of starting projects with short-term funds, without long-term maintenance plans, using a plantation site of “Penny Pines” as an example. In the Penny Pines program, school children have donate pennies to plant conifers in California national forests following disturbances—enough to provide 27 million seedlings since 1941. Unfortunately, insufficient funding for maintenance has created dense stands that now present a hazardous fire situation. Participants in FireScape Mendocino are working ensure that their projects will be resilient to financing challenges. **California:** Last week the **Western Klamath Mountains FLN** completed its **fifth workshop** in the series designed to **collaboratively set priorities** for areas in the Klamath and Six Rivers National Forests. The Forest Service, National Forest Foundation and others are supporting concurrent GIS-based **treatment prioritization** modelling by the Karuk Tribe and others. Together, these efforts will highlight areas where treatments on both Forest Service and private lands would meet **multiple objectives**, such as treatments in traditional food-gathering areas would meet Tribal objectives for food security and reduce fuel loads as well. **Georgia:** According to **Mike Brod** ([mbrod@fs.fed.us](mailto:mbrod@fs.fed.us)), last Wednesday “was a **monumental day for mountain burning** in Georgia. We had **two 2,000-acre conservation burns** going simultaneously on this district, about five air miles from each other. No telling how many [press releases](#), radio interviews and personal visits we have done over the past two weeks. Smoke dispersion was beautiful, fire effects were beautiful, interagency cooperation was beautiful, and PR was beautiful.

**Tallulah Gorge** burnt amazingly, and **Nathan Klaus** did an excellent job as burn boss. This unit has had three fires in past seven years—it just **keeps getting better**. We are **revitalizing the pyrogenic culture** in the mountains.” Mike adds that thanks are due to all partners in this landscape, especially the **Georgia Department of Natural Resources**, **Georgia Forestry Commission** and **The Nature Conservancy**.

**Iowa:** Fire partners in the **Loess Hills** held their **quarterly meeting** last week. In spite of the relentless cold, turnout was good, with **19 partners** turning out to **coordinate for the spring burn season**, plan **cooperative burns**, and share information about upcoming trainings. Also on the agenda was a **farewell** to the Conservancy’s Loess Hills fire coordinator, **Kyle Lapham** ([klapham@tnc.org](mailto:klapham@tnc.org)); Kyle is starting with the Conservancy’s **Arkansas chapter** this week (where he’ll be working with McRee Anderson).

**North Carolina:** Twenty-two practitioners from 14 state, federal and NGO partners met recently to review a **restoration needs analysis** developed by Conservancy staff and determine approximate **acreages in need of treatment** (and **realistic treatment goals**) needed to restore sustainable forest vegetation structure and composition for **six forested systems**. This work will span the North Carolina portion of the Southern Blue Ridge, beginning with 1.1 million acres of land under Forest Service ownership. **Oregon:** An **interview** with **Kerry Metlin** and **Marty Main** about the **Ashland Forest Resiliency Project** ran on Jefferson Public Radio last week. This **collaborative, cross-boundary work**—supported in part by **Scaling-up to Promote Ecosystem Resiliency** funds—is aimed at protecting the city’s water supply, as well as significant habitat and recreational values. During the interview, Kerry and Marty talk about some of the **give and take** needed when **managing for multiple objectives** across a landscape. **Virginia (and beyond):** The **Central Appalachians FLN Monitoring Working Group** recently held a **webinar** to work through **exercises on reporting and analyzing data** in the FEAT/FIREMON Integrated (FFI) database. Staff from **The Nature Conservancy** and the **George Washington and Jefferson NFs** have **built a shared database** in FFI for forest structure and composition monitoring data collected from controlled burns—“a **critical component of our adaptive management** framework,” according to **Marek Smith**.

In the webinar, FFI project lead **Duncan Lutes** (Rocky Mountain Research Station Fire Sciences Lab) facilitated the group’s work through six exercises to summarize metrics such as canopy cover and seedling densities, illustrate the **importance of SMART objectives**, and evaluate **statistical significance** of results. The exercises were designed using specific queries from collaboratively-developed monitoring objectives and indicators. Another webinar is planned for those who could not attend. ## Funding: CSU Database / FAC Mitigation Funding

**CSU Database:** The **Colorado State Forest Service** hosts a **database** of **natural resources grants and assistance programs**; while many are specific to Colorado, others cover wider geographic areas. (The database is not compatible with older versions of Internet Explorer; if the program list doesn’t appear under the list of categories, try using Firefox or Chrome. Note that TIS asks that you download these directly from the vendor, [Mozilla](#) or [Google](#), rather than through a third party site.)

**FAC Mitigation Funding:** The website **fireadapted.org** has a **grants and funding page** with links to various potential sources of funding for community **wildfire mitigation work**. Included is information about FEMA Fire Prevention and Safety grants, the Hazard Mitigation Grant Program, assistance under the National Fire Plan, and a directory of state resources.

## Resources: Birds & Burns / Firewise Starter Kit

**Burns & Birds:** For those working in **dry mixed conifer forests**, the **Forest Service Birds & Burns Network** may provide useful information (or contacts). Target species are mainly cavity nesting birds, which serve as **indicator species**.

**Firewise Starter Kit:** A **new edition** of the **Getting Started with Firewise Kit** is now available from NFPA.

## Articles: Risk Management & WUI Fires / Bats

**Risk Management:** The [article](#) “How **Risk Management Can Prevent Future Wildfire Disasters** in the Wildland-Urban Interface” proposes the need to **change the perception** of WUI fire disasters from a **wildfire control problem to a home ignition problem**. “If our problem statement is defined as keeping wildfire out of the WUI, it is unobtainable, and large wildfires and residential disasters will continue.... By contrast, if the problem is identified as home ignition, mitigation of the [home ignition zone] is the most cost-effective investment for reducing home destruction.”

## In the News: More Fire / Reduce Wildfire Risk

**More Fire:** Articles about “**Fostering Resilience in Southwestern Ecosystems: A Problem-Solving Workshop**” held recently by the **Southwest Fire Science Consortium** ran in both the *Santa Fe New Mexican* (“Experts Debate Challenges of Adapting to Wildfires” ([link](#))) and the *Arizona Daily Star* (“**The Answer to Forest-Destroying Fires is More Fire**, Researchers Say” ([link](#))). Anne Bradley noted that “the press picked up on our point that we need more fire to prevent bad fires. They did a good job of communicating that message.”

**Reduce Wildfire Risk:** Central Oregon station KTVZ [reported on](#) a **public opinion survey** conducted on behalf of the Oregon Forest Resources Institute (working with the Deschutes Collaborative Forest Project). The **top priority** among those polled was to “**manage forests to reduce high-severity wildfire risk**,” with thinning and burning treatments receiving high approval scores.
