## News from the Field

**Arkansas:** Partners got about **300 acres** of Scaling-up to Promote Ecosystem Resiliency (**SPER**) burning done in the **Devil's Eyebrow Natural Area** last week. (There are a couple [pictures](#) on the Arkansas Forestry Commission's Facebook—but it's a very active page, with lots of prescribed fires going on, so a long scroll down.)

**California:** KMUD radio aired an **hour-long interview** last week with **Will Harling**, **Nolan Colegrove**, **Josh Saxon** and **Kimberly Baker** about the effective collaborative work of the **Western Klamath Restoration Partnership** and **Six Rivers National Forest**, including the **role of the FLN** in getting them where they are today. The program is in the [station's archives](#) (sort by show name; it's the January 27 episode of Environment Show; download may work better than play).

**California:** And from the same landscape, an [article](#) by **Will Harling** ([will@mkwc.org](mailto:will@mkwc.org)), "Learning Together, Burning Together," is the **cover story** for the latest issue of *Wildfire Magazine*. The article nicely traces the **winding, years-long path** that led to last fall's **Klamath River TREX**.

**Colorado:** The **Pike's Peak FLN** met last week to finalize their **charter** and discuss potential **projects** for implementation. Among the outcomes of this workshop were:

- A commitment to **collaboratively support a broadcast burn** on the Sourdough Project near Woodland Park: This project, led by the Coalition for the Upper South Platte, is very near the Forest Service's Highway 67 West project, so both the burn plan and communication and outreach plan will be developed with **both projects in mind**.
- Identification of a sub-group to develop a **communications and outreach strategy**: They will draft key messages for the larger FLN effort and recommendations for **engaging community members** and other critical partners in monitoring and field visits at the project site..

**North Carolina:** Optimal weather conditions—and **excellent preparation**—allowed **Southern Blue Ridge FLN** partners to take advantage of a somewhat **unexpected late January burn window**. North Carolina Wildlife Resources Commission (NC WRC) completed a 200-acre prescribed burn on the Needmore Game Land with help from TNC, as well as burns on both Thurmond-Chatham and South Mountains Game Lands, and on a US Forest Service Fire Surrogate Studies site at Green River Game Land. With assistance from The Nature Conservancy and the NC Forest Service, NC WRC and the US Forest Services also cooperatively burned the **1,950-acre** Lake James Unit as part of the **Grandfather Restoration Project** (CFLRP) to reduce fuels and restore fire-adapted vegetation. **National:** The **semi-annual report** for our agreement was submitted last week, with more than 60 pages detailing the work of the FLN, FAC Learning Network, TREX and SPER. **Thank you to everyone** who did the work—and the paperwork—to make it all happen. **Some of the highlights** were selected and incorporated into a few pages of overview and illustrative examples. ## Nominations: Innovative Suppression

**Innovative Suppression:** In an effort to recognize innovative **suppression methods** that **support the long-term viability of landscapes**, the **Southwest Fire Science Consortium** is seeking nominations for two awards—for the [incident strategy](#) of the year, and suppression tactics (individual or group). Nominations are due by **February 23** (the forms need to be downloaded before being filled in).

## Resources: Quick Guides / Final Planning Directives / Networks Blog

**FAC Quick Guides:** The first of a series of “quick guides” to be produced by the **FAC Learning Network** is now available. The first subject to be addressed is **increasing watershed resilience**, based on the **experiences of FAC hubs** in Ashland (OR), Flagstaff (AZ), Santa Fe (NM) and the Upper South Platte watershed (CO). The guides will all be posted at <http://facnetwork.org/resources/network-quick-guides/>.

**Final Planning Directives:** The **Forest Service's 2012 Planning Rule** is intended to provide “a collaborative and science-based framework for creating land management plans which will support ecological sustainability and contribute to rural economies.” After a process that included a great deal of public input, the final planning directives—the key set of **documents that guide implementation** of the rule—are [now available](#), effective January 30.

**Networks Blog:** The blog “**Connecting to Change the World**,” by Peter Plastrik (author of the book of the same name, in which the FLN is a case study) has some interesting posts on networks for social change. (A [recent post](#), about learning together by reading together, has some familiar names and faces.)

## Reports & Articles: CFLRP / Beargrass / Fuel Breaks for Grouse / Review Opportunities

**CFLRP:** A group of researchers from the University of Michigan produced the [report](#) “Restoring Forests and Communities: **Lessons from the Collaborative Forest Landscape Restoration Program**.” The in-depth report includes project summaries of each of the 13 projects that started in 2012 (including key challenges and strengths), cross-case analyses, and **recommendations** (many of which can **apply to collaborative groups more generally**).

**Beargrass:** The [study](#) “Forest Site Classification for Cultural Plant Harvest by Tribal Weavers Can Inform Management” merges “**traditional ecological knowledge** with **scientific ecological knowledge** to understand how different knowledge systems can apply to forest management,” using beargrass as an example.

**Fuel Breaks for Grouse:** A Nature Conservancy team has completed the [report](#) “**Designing Regional Fuel Breaks** to Protect **Large Remnant Tracts of Greater Sage-Grouse Habitat** in Parts of Idaho, Nevada, Oregon, and Utah” for the Western Association of Fish & Wildlife Agencies. The team used **GIS modelling methods** to identify general locations where fuel breaks may help protect this species from uncharacteristically large or frequent wildfires.

**Review Opportunities:** The latest [white paper](#) from the [Ecological Restoration Institute](#) is “**Administrative and Legal Review Opportunities for Collaborative Groups**,” which provides information about the Forest Service’s administrative and judicial review process of CFLRP projects, and opportunities for participating as a collaborative group at both levels.

## FLN Prescribed Fire Training Exchanges

- February 15-23\*** **Klamath River Communities TREX / Weitchpec, CA**  
This TREX, hosted by the Yurok Tribe and FLN, will provide training opportunities to local and regional fire practitioners while completing local priority burns. (The application deadline has passed.)  
\* Dates are tentative. To accommodate weather contingencies, participants will be fire-ready and on-call starting February 1. If the TREX needs to be moved earlier, 48-hour notice will be given to participants to mobilize in Weitchpec.
- February 15-28** **North Carolina Prescribed Fire Training Exchange / Ellerbe, NC**  
The North Carolina Prescribed Fire Council, Southern Blue Ridge FLN and numerous other partners will host this TREX in the sandhills and piedmont region of the state. (The application deadline has passed.)
- March 14-29** **Niobrara River Valley TREX / Ainsworth, NE**  
This “spring break TREX” will integrate a diverse group of fire practitioners, including university students; municipal, state, federal and contract firefighters; and other natural resource managers, scientists and researchers. It will provide experiential learning opportunities through a series of controlled burns on The Nature Conservancy’s Niobrara Valley Preserve and the U.S. Fish & Wildlife Service Fort Niobrara NWR. (The application deadline has passed.)
- March 16-27** **Lower Loup Valley TREX / Broken Bow, NE**  
This TREX will focus on about 5,000 acres of privately-owned grassland that is used for livestock production. Prescribed fire is being used to manage eastern redcedar and promote habitat for grassland-dependent species such as the greater prairie chicken. The TREX is a partnership between Pheasants Forever, The Nature Conservancy, the Fire Learning Network, and the Rainwater Basin Joint Venture. A grant from the Nebraska Environmental Trust Fund has provided financial resources to allow participating landowners to rest the land from grazing in order to build up fuel that will increase the effectiveness of the burns. (The application deadline has passed.)

## Fire Learning Network Notes from the Field



### Lake James Prescribed Burn

Grandfather Restoration Project (Collaborative Forest Landscape Restoration Program)  
Central Escarpment Landscape, Southern Blue Ridge FLN

January 2015

#### Lake James Rx Burn

**Date:** January 28-31, 2015

**Size:** 1,950 acres (about 1,720 acres USDA Forest Service; 230 acres North Carolina Wildlife Resources Commission)

**Location:** north of Lake James Road, south of Dobson Knob

**Purposes:** fuel reduction, restoration of fire-adapted vegetation

**Partners:** North Carolina Forest Service, North Carolina Wildlife Resources Commission, The Nature Conservancy, USDA Forest Service (Appalachian RD, Grandfather RD, Pisgah RD)

**Treatment #:** second entry with prescribed fire

After a few unsuccessful tries at the end of last spring's burning season, when the weather failed to cooperate, partners hiked back up the mountain to try it again. The 1,950-acre Lake James burn was split into two sections, with an upper section of 850 acres and a lower one of 1,100 acres. There was great weather on the first day. Burning was delayed by an equipment malfunction that held up the helicopter, but another helicopter was available, allowing the completion of the upper 850-acre section. The next day, work began on the bottom portion; this was stalled shortly after noon by an unpredicted rain shower, allowing ignition on only about 50 acres. The following day had very high

winds, so the crew worked to monitor the burn, with no active firing. On the fourth day, the weather finally cleared up again for a great day of burning that allowed completion of the remaining acres.

**FLN monitoring plots** had been installed in this unit by Forest Stewards and Western Carolina University, who will also collect the post-burn data next year. Partners are particularly looking forward to seeing the results, since this was the second time the unit has been burned, and the effects of multiple burns within a single unit on the Grandfather District are of great interest.

**Smoke monitoring** is part of the Grandfather project's smoke management program, and on this burn mobile smoke monitoring stations were deployed for the first time. Grandfather District staff are assessing the information and will share through a blog post on <https://grandfatherrestorationproject.wordpress.com>.

With a window of dry weather in the last few days of January, partners on the Grandfather Restoration Project carried out a large burn at Lake James. This was a true collaborative burn, with the unit including both North Carolina Wildlife Resources Commission and U.S. Forest Service land, and the crew including The Nature Conservancy as well.
