News from the Field

California: The Monterey Fire Safe Council and Forest Service hosted a Wildfire Preparedness Day in Cachagua, the first such event in Monterey County. The event was a success, with more than 150 people attending, and 50 signing up for involvement with the FSC or learning more about getting fuel reduction work done. Georgia: After an 80-year hiatus, peregrine falcons are back at Tallulah Gorge, a Southern Blue Ridge FLN focal area. According to Nathan Klaus, "Getting this apex predator back is just one more step on the road to recovering a healthy ecosystem ... and is one of the dividends, large and small, that come with restoration. I don't think it is a coincidence that the birds showed up now, after we have been working there for almost ten years. A number of birds were released there in the 1980s and 90s, prior to our restoration effort and none stayed, now that we've got a healthy landscape they found it themselves. We already know that burning around Tallulah Gorge has increased the bird population and opened up the habitat. Peregrines are almost exclusively bird eaters and they need open habitats to hunt." With more than 90 visitors coming to see the falcons in just a week, it appears that healthy ecosystems are good for ecotourism as well as for falcons. Oregon: In spite of a rainy forecast, the **Central Oregon Prescribed Fire Training Exchange** went ahead as planned. Participants were busy with a **full curriculum** of classroom and field learning, then took advantage of good burn windows to complete **191 acres of treatments and hands-on training**. For more, see the attached *Notes from the Field*.

While going through the town of Sisters in full fire gear, **checking for smoke impacts** from the TREX, Jeremy Bailey **was lectured several times** by community members. The **Northwest FLN** has a **long history** in this landscape, and people seem to have taken in the messages—he couldn't get a word in edgewise as **people went on about the importance of prescribed fire**, and how they'd **rather have some smoke tonight than wildfire** smoke later.

Oregon: Elsewhere in the state, the Southern Oregon Forest Restoration Collaborative, Bureau of Land Management and Applegate Fire District 9 helped some middle-school students get their school ready for fire season—and raised wildfire preparedness awareness in the community. Washington: NPR ran a <u>story on Morning Edition</u> about what the **Chumstick Wildfire Stewardship Coalition**, the state of **Washington** and the **Forest Service** are doing **together to reduce wildfire risk** in that community through adaptation to fire. **Annie Schmidt** did her usual wonderful job of laying out the challenge and the mitigation practices—and the story highlighted how the state, Forest Service and locally-based coalition folks are all on the same page talking about what they are doing together to address the issue.

Reports: Position Statement / Quadrennial Review / WUI Fire Spread

Position Statement: The Association for Fire Ecology, International Association of Wildland Fire and The Nature Conservancy have released the joint, rather bluntly-titled position statement, "Reduce Wildfire Risks, or We'll Continue to Pay More for Fire Disasters." Much of the document is devoted to defining the costs of wildfires—which can be 2 to 30 times the official direct costs most widely reported, once the indirect and post-fire costs are included. Suggested remedies include more investment in preparedness, reducing barriers to fuels mitigation, increasing the use of prescribed and managed fire, and better tracking of economic losses to update risk rating systems.

Quadrennial Review: The 2014 Quadrennial Fire Review was released earlier this month. The review is "a strategic assessment process conducted every four years to evaluate current wildland fire management community strategies and capabilities against best estimates of the future environment." The assessments in this include both recent trends (including summaries of climate/fire trends) and a section on the 10-20 year outlook.

WUI Fire Spread: With support from the National Fire Protection Association, The Fire Protection Research Foundation has produced the <u>report</u> "**Pathways for Building Fire Spread at the Wildland Urban Interface**." The report's contents include a literature review, case studies, mitigation strategies and risk assessment methodologies.

Article: Estimating HRV

Estimating HRV: The authors of the <u>article</u> "A State-and-Transition Simulation Modeling Approach for Estimating the Historical Range of Variability" developed a method for "using LANDFIRE state-and-transition models to estimate the historic range of variability around the mean reference condition for each model state in ecosystems by varying the fire probabilities."

Central Oregon Prescribed Fire Training Exchange

Bend, Oregon May 14-21, 2015

Notes from the Field Thirty-five firefighters, conservation

Thirty-five firefighters, conservation stewards and managers gathered to learn about the social and ecological challenges and opportunities for the use of prescribed fire in the forests, shrublands and grasslands of Oregon. Hosted by the Central Oregon Fire Management Service—a joint BLM-USFS program—and TNC, and with participation from the Oregon Prescribed Fire Council and the University of Idaho, this was the first prescribed fire training exchange in Oregon.

Despite a rainy start, the team remained patient and focused. Participants spent time in the classroom, as planned, and went on field trips. And in spite of the forecast, they were able to find weather windows and burn units where fire could be used to meet ecological and training objectives, as well as opportunities for local community engagement and outreach. A few days in, participants implemented a controlled burn on the Deschutes National Forest, and two more days of burning followed.



It wasn't all ponderosa: participants discussed the ecology of sage-steppe ecosystems on a field tour. Classroom and field learning, as well as burning, were key to the event's success.

By taking advantage of brief, unexpected burning windows, this TREX was able to complete 191 acres of needed treatments that would otherwise likely not have been done this year, as local crews had had to turn their focus to preparing for the wildfire season.

Over the course of the event,

participants learned and practiced a variety of skills—including interviewing with the media, speaking with the public about beneficial fire and monitoring the effects of fire on vegetation, as well as implementing controlled burns. Diverse teams were tasked with igniting and holding prescribed fires, and monitoring and documenting fire effects. They also worked with local community members to promote the use of fire in and around communities—helping pave the way for safer communities and fire-adapted ecosystems restored to a healthier, more resilient condition.

Southern Oregon Middle-School Students Get Wise to Fire

Notes from the Field

April-May 2015

Students at Ruch School in Jacksonville, Oregon learned about becoming better adapted to fire and created a Firewise demonstration site at their school.

The Southern Oregon Forest Restoration Collaborative

(SOFRC), Bureau of Land Management, Applegate Fire District 9 and Ruch School middle-schoolers came together this spring to help get their community ready for fire season.

Students learned about fire science, fire behavior, fire adapted ecosystems and communities, and the three zones that make up a defensible space. Then they put what they learned into practice—they assessed their own school, then helped make it a Firewise demonstration site. The work included planting fire resistant plants and clearing fuels on the school grounds, as well as installing signs to explain defensible space. Students then went to their own homes to assess them for potential fire hazards.

Beyond the School

Students also nominated vulnerable members of the community to receive assistance from Oregon Department of Forestry crews to do fuel reduction work around their homes.

A \$500 Firewise grant for community projects offered by the National Fire Protection Association sponsored by State Farm—one of just 65 awarded nationwide--provided funding for this project. Other support came from Plant Oregon and community members, who donated plants, and Advanced Landscape Services donated mulch.



















From Ainsworth: West 9.5 miles on Highway 20 to Nordan Avenue; North 16 miles to kiosk.
