## News from the Field

**California:** From Hayfork, **Michelle Medley-Daniel** ([michelle@thewatershedcenter.com](mailto:michelle@thewatershedcenter.com)) has posted her **resident's-eye-view** of one of the northern California fires (the **Fork Complex**) on the [FAC Net blog](#). In addition to sharing a sense of what it's like to live with thick smoke—and uncertainty—for weeks on end, there are some **practical smoke links** at the end.

**Georgia / Appalachians:** The **FAC Net** here continues to **expand its influence** beyond its original scope in Towns County, sharing fire adapted communities concepts through a variety of venues. The **Chestatee-Chattahoochee RC&D** recently had a Firewise/Fire Adapted display at the **county fair in neighboring Rabun County**, for example. **Frank Riley** is also participating in the Georgia Academy for Economic Development, which includes many **key economic players** in north Georgia, and will be spreading the word through those channels. Along with **Mike Davis**, he also recently met with the New River Highlands RC&D in **Wytheville, Virginia** and the Blue Ridge RC&D in **Bakersville, North Carolina**, and Frank will be speaking to two RC&Ds in **southwest Georgia** later this month. **Idaho (and Colorado):** The **Island Park Sustainable Fire Community** is **taking advantage of smoky skies** to encourage community members to take part in its upcoming slash pickup days. The PSA script begins "Although the smoke in the air is **from distant fires**, Island Park residents are **urged to prepare** their properties for **wildfires that will strike closer** to home..." then explains a few ways homeowners can help make their properties safer, and announces the slash pickup dates. **Rebecca Samulski** ([montezumafirewise@gmail.com](mailto:montezumafirewise@gmail.com)) of **FireWise of Southwest Colorado** **borrowed their idea** for a [story](#) in the *Cortez Journal*, "No Better Time to Prepare Your Property for Wildfires."

**Minnesota:** **Dovetail Partners** produced the [report](#) "Fire Adapted Communities: Nationwide Efforts and Community-Based Tools for Living with Wildfire." It includes an introductory **overview of various programs and efforts** currently aimed at **helping communities** become better **adapted to wildfire**. **North Carolina:** As reported earlier, the **effectiveness of fuel treatments** conducted as part of the **Grandfather Restoration Project** played a major role in the decision to manage the July **Bald Knob wildfire for resource benefits**. A more [in-depth discussion](#), with maps and photos, has been written up by **Clint Cross** (Regional Fuels Specialist, R8) and **Jim Menakis** (Fire Ecologist, WO).

**Oregon:** A **community outreach tour** of the **Ashland Forest Resiliency Project** was the [front page story](#) in today's *Ashland Daily Tidings*. **Darren Borgias** ([dborgias@tnc.org](mailto:dborgias@tnc.org)) is quoted on the value of this kind of community engagement: "It's so important to get people out here in the watershed to have this discussion," he said. "Sometimes when you get into a conference room, with all the arm-waving and shouting, people have a hard time coming to an agreement. **Out here** where you can look up and **see what the issues are** and **discuss solutions**, it's easier to **get on the same page.**"

**Washington:** In the midst of the record wildfire season in the state, **Mary Sutton Carruthers** ([mccarruthers@tnc.org](mailto:mccarruthers@tnc.org)) and **Reese Lolley** ([rlolley@tnc.org](mailto:rlolley@tnc.org)) have written a post for a [Conservancy blog](#) about the need for **communities to adapt to wildfire**. In their post, they mention the **value of collaboratives** like the **FLN** and **FAC Net**—and introduce the **new Washington State Fire Adapted Communities Learning Network**.

**Washington:** A special **multi-partner team** has been deployed to north-central Washington in a **pilot effort** to support fire adapted communities strategies in an area currently facing several large fires. The team will work with the **Chumstick Wildfire Stewardship Coalition** to schedule and deliver home assessments and training and to identify opportunities to **assist communities during large fire events**. The team will also be documenting lessons and stories from the field. **Michelle Medley-Daniel** will be in touch with the FAC Net through their online workspace during the assignment, and will share lessons more widely afterwards.

**Prescribed Fire Training Exchanges:** A **new fact sheet about TREX** is available on the Conservation Gateway—just as the fall training season is about to get underway. **Three TREX are scheduled** for the coming weeks: the Spanish-language TREX (September 15-October 5) in **New Mexico**, and the Klamath River (September 29-October 11) and NorCal TREX (October 20-November 1) in **northern California**.

## Resources: Fire Myths / Virtual Tour

**Fire Myths:** The *Washington Post* [opinion piece](#) “**Five Myths about Wildfires**” does a nice job of briefly **laying out—and then refuting—five big myths** about wildfire. It includes mention (though not in so many words) of the value of fire adapted communities practices. It covers a lot of key messages **very concisely**—likely a piece worth flagging for referring people to for “**Wildfire 101**.”

**Virtual Tour:** The **North Atlantic Fire Science Exchange** recently hosted a **fire science tour** in **New Jersey’s pine barrens**, attended by 25 people. For those who couldn’t make it, a **virtual field trip** was created on Google Maps, complete with **photos** and detailed **notes for each stop**—an interesting way to document and share the tour and its learning. ## Articles: Fire Ecology / Understory Plants

**Fire Ecology:** The [August issue](#) of *Fire Ecology* is now available. Among the articles are “**Vegetation Response to Burn Severity, Native Grass Seeding, and Salvage Logging**” (Penelope Morgan et al.), “**Principles of Effective USA Federal Fire Management Plans**” (Marc D. Meyer et al.) and “**Pile Burning Effects on Soil Water Repellency, Infiltration, and Downslope Water Chemistry in the Lake Tahoe Basin, USA**” (Ken R. Hubbert et al.).

**Understory Plants:** A [story](#) in *ScienceDaily* reports on a recent paper by Jens Stevens and colleagues, “**Forest Disturbance Accelerates Thermophilization of Understory Plant Communities**.” They report that in burned areas in California, species from further south are increasingly represented in the understory regrowth—but that **areas thinned before wildfire** “burned less hot and therefore left some tree canopy, allowing for both northern and southern plant species to coexist.”

### **Compositional and Structural Changes over Time with Different Fire Regimes in Linville Gorge, NC**

In this **Southern Blue Ridge FLN** webinar (originally scheduled for August 18), **Cassandra Pallai** will discuss research conducted in Linville Gorge based on resampling plots originally put in during 1992 for her Master’s project at Duke University. The plots have been resampled (by Waldrop and others) periodically and give a nice sampling of different fire regimes in Linville. Plots within the Table Rock Fire footprint were recently sampled, and Pallai combined those results with the original sampling and Waldrop’s resampling to study compositional and structural changes over time with different fire regimes.
