#### News from the Field

Colorado: FAC Net affiliate members Einar Jensen (South Metro Fire) and Jim Webster (Wildfire Partners) were among those featured in a 30-minute TV news feature about Colorado's wildland-urban interface last week. They emphasize the fact that Colorado's ecosystems exist because of fire, and that residents, must therefore find ways to adapt. (For even more, see the full 16-minute panel interview, where the Einar and Jim discuss topics ranging from residents' attitudes toward government and their perception of risk, to misconceptions about home mitigation, and the importance of planning for evacuation and recovery.)

Colorado / New Mexico: Coalitions and Collaboratives Inc. has announced the six recipients of the second round of their Action, Implementation and Mitigation Partnership awards. Two FAC Net member organizations—Wildfire Adapted Partnership and the Forest Stewards Guild—are among the recipients. These awards will allow Wildfire Adapted Partnership to meet the expected increase in demand for its structure risk assessments and defensible space projects, and will provide support for the Forest Stewards Guild's Gravitas Peak Fire Module. Idaho: The Island Park Sustainable Fire Community was recently featured as a case study by the Tools for Engaging Landowners Effectively project. The post "Leveraging Norms for Wildfire Preparedness" looks at how IPSFC is addressing its challenges—including numerous part-year residents—by reducing barriers to preparedness action for seasonal residents, and through events that integrate the norm of wildfire preparedness into the greater community.

New Mexico: With support from FAC Net and others, the Forest Stewards Guild and Fire Adapted New Mexico launched a HEPA filter loan program last year as part of a larger effort to help northern New Mexico residents cope with inevitable smoke from prescribed burns and wildfires. This year partners in the area are getting the word out about the loan program and other resources through public information officers and press releases. Oregon: Partners from the FLN and FAC Net hosted a public tour of a prescribed burn earlier this month. Among the participants in the tour was the new editor from a local paper, who captured the key messages well in the <a href="story">story</a> "Why the Forest Must Burn." (For more detail, see the <a href="brochure">brochure</a> developed for the tour.) This tour was part of a broad multi-partner public outreach campaign in central Oregon; for more from the campaign, see the Videos section below.

Oregon / Washington: Ryan Haugo (<a href="mailto:rhaugo@tnc.org">rhaugo@tnc.org</a>) and Kerry Metlen (<a href="mailto:kmetlen@tnc.org">kmetlen@tnc.org</a>) are among the co-authors of the <a href="mailto:article">article</a> "The Missing Fire: Quantifying Human Exclusion of Wildfire in Pacific Northwest Forests, USA." The team quantified expected versus observed fire activity for the roughly 50 million acres of forested land in Oregon and Washington, finding that between 1984 and 2015, large wildfires burned about 8 percent of the total forested area—an order of magnitude less than would be expected under historical fire regimes. "Popular perceptions that too much fire has burned in Pacific Northwest forests, particularly during record wildfire events in 2014 and 2015, are

unfounded from an ecological perspective based on burned area alone but supported when stratifying by fire severity." And while fire is critical to these forests, "fire severity outside of the range of adaptation neither restores nor maintains; rather, it serves to further reduce landscape resilience." (**Highlights** from this research are on the Conservancy's website.)

**Southern Blue Ridge**: The outreach team from last fall's **Southern Blue Ridge TREX** has produced some nice summaries and stories from the event, including a **by-the-numbers** <u>fact sheet</u>, a <u>storymap</u> (with embedded videos of a **SimTable training**, a **drip-torch-eye's view** of firing ops, and **participants sharing their stories**) and a <u>video</u> narrated by **Tom Dooley** (<u>tdooley@tnc.org</u>). WTREX: The Southern Fire Exchange produced a highlights <u>video</u> from the Women in Fire TREX held at Tall Timbers Research Station earlier this spring.

### Opportunities: Cohesive Strategy Working Groups / PPE Pants

Cohesive Strategy Working Groups: The Western Regional Strategy Committee Group is launching three work groups to address significant issues across the West. They have <u>put out a call</u> for people who would like to be a part of the Post Fire Impacts Working Group, Improving Wildfire Response Working Group or Increasing the Use of Prescribed Fire Working Group.

**PPE Pants**: The **Forest Service** National Technology and Development Program (NTDP) is conducting a **product review of pants design** for the firefighter pant specification it administers. Check out the <u>questionnaire</u>, which focuses on the **fit and function** of the three models primarily worn by firefighters.

### Resources: Fire Weather / Environmental Assessment / Defensible Space

**Environmental Assessment**: The **Cherokee National Forest South Zone Collaborative Group** recently finalized a set of **recommendations and sideboards** to be used in developing a programmatic environmental assessment for restoration activities. In addition to drafting a set of recommendations, the group captured their <u>lessons learned</u> in **working as a collaborative** on the project. **Defensible Space**: The **Insurance Institute for Business and Home Safety** recently **exposed a duplex** to a shower of **embers** in its South Carolina <u>research facility</u> to test—and demonstrate—the effectiveness of defensible space and **fire-resistant materials**, which were used one on side of the building. The <u>NPR story</u> "Step 1: Build A House. Step 2: Set It On Fire" takes a good in-depth look at the results.

# Articles & Reports: Resilience / Using Science / Values Mapping / Overlooked Forest Type / Forests & Carbon

Resilience: The <u>article</u> "Integrating Subjective and Objective Dimensions of Resilience in Fire-Prone Landscapes" examines the concept of "resilience"—which differs between ecology and many social sciences—using managing for the resilience of social-ecological systems to wildfire as an example. **Using Science**: The <u>article</u> "Use of Science and Modeling by Practitioners in **Landscape-Scale Management Decisions**" is based on **survey of about 200 Forest Service managers**. Among other things, the authors found that managers more often accessed with science through research publications than direct engagement with scientists, and that they believed science should weigh more heavily in decision-making in cases of low public consensus than high.

Values Mapping: The brief <u>article</u> "Is Recreation a Landscape Value?: Exploring Underlying Values in Landscape Values Mapping" suggests that a clearer picture may emerge when "recreation" is not included. Recreation may encompass several (possibly conflicting) values, and "it is far easier to identify a behavior or set of activities than it is to elicit the values influencing that behavior.... Those without recreation as an option in the typology were forced to have a more complicated conception of the benefits and values that are derived from the places they referenced on the maps."

Overlooked Forest Type: The authors of the <u>article</u> "Recalling Open Old Growth Forests in the Southeastern Mixed Forest Province of the United States" used about 81,000 historical tree records to look at southeastern forests in the 1800s. They conclude that "ecologists and foresters generally have overlooked an ecologically important ecosystem"—open old growth forests—"and thus have not interpreted adequately the full range of forest diversity."

**Forests & Carbon**: The <u>publication</u> "Greenhouse Gas Emissions and Removals from Forest Land and Urban Trees in the **United States**, **1990-2017**" gives a brief overview of fluxes of GHG for U.S. forests over the last three decades. Later updates will report a state-by-state basis (and the information is currently available by request).

### Videos: Quick Rx Intro / Inside a Fire / CMAT

Quick Rx Intro: The Deschutes Collaborative Forest Project has released a top-notch set of four videos that introduce aspects of safe controlled burning for forest restoration and community protection. While clearly set in central Oregon, the concepts presented are completely transferable to other landscapes—prepping for a burn (1:08), key personnel and what they do (1:52), conducting the burn (2:19) and mop-up (0:46). The videos will play at local theaters and shared through social media. For more about this project, contact Ed Keith (ed.keith@deschutes.org).

**Inside a Fire**: A <u>brief video</u> captures a **prescribed fire creeping** through a patch of the **Chattahoochee-Oconee National Forest** in Georgia.

**CMAT**: A new <u>video</u> from the **National Interagency Fire Center** gives a quick introduction to **Community Mitigation Assistance Teams**, and how they assist agencies, community residents and leaders to identify mitigation opportunities before, during and after wildfires. ### Action, Implementation and Mitigation Grants Awarded

Mentoring and Capacity Building for Local Organizations

Lake George, CO - Coalitions and Collaboratives Inc. (COCO), has announced six recipients of their Action, Implementation, and Mitigation Partnership (AIM-P) award. In this second round of the program, a combined \$217,000 will be awarded to six organizations, through funding generously provided by the U.S. Forest Service. Competition this round was high, with 28 organizations seeking a combined total of just over \$1 million dollars.

The competitive awards are geared towards helping organizations increase the scale and pace of wildfire mitigation activities by enhancing their capacity in some way - either through the addition of personnel, the purchase of equipment, wildfire reduction planning efforts, or funding a key wildfire-risk reduction project.

#### The Round 2 recipients are:

- Blackfoot Challenge, Ovando, MT -- Blackfoot will increase their capacity for essential prescribed fire cooperative burning in northern Montana. Funding and technical assistance will help the organization develop crossboundary prescribed fire maintenance projects near high risk Wildland-Urban Interface communities.
- Forest Stewards Guild, Santa Fe, NM -- Will increase capacity through the development of a prescribed fire group, the Gravitas Peak Fire Module, which will work in Colorado, New Mexico and Arizona as well as other states to support training and implementation of prescribed fire in high-risk areas. Their first projects are slated for Angel Fire, NM and Colorado Springs, CO. The program trains underprivileged youth, providing them with meaningful and impactful work that will prepare them for future careers in fire and mitigation.
- Klamath Watershed Partnership, Klamath Falls, OR -- In a partnership with local fire departments, Oregon Division of Forestry and residents, the Partnership will purchase a piece of forestry equipment, available to all partners, that will increase acreage treatment from one acre a day to over six acres of reduced risk a day. Mentorship will help them create the

lease agreements, develop maintenance plans and increase resident involvement.

- Mt. Adams Resource Stewards, Glenwood, WA -- With AIM-P support, MARS will be able to hire a Resources Crew Lead to support the implementation of a partnership project on federal and private lands and purchase essential fuels, forestry and safety equipment. COCO has supported Mt. Adams Resource Stewards with guidance in the creation of their crew.
- Saws & Slaws, Boulder, CO -- This grassroots, volunteer-powered organization will use their funding to increase their effectiveness and impact by hiring their first-ever, part-time Program Coordinator. Their model, people working to protect their homes, is one they hope to share across the country. Their activities include creating defensible space and providing firewood to low income residents.
- Wildfire Adapted Partnership, Durango, CO -- AIM funding will allow the
  organization to continue their cost-share program to implement
  defensible space projects in high-risk WUI areas. In addition, the
  organization will increase their capacity to complete structure risk
  assessments, which are proven to lead residents to take action and harden
  their structures. The demand for assessments is expected to increase
  after last year's 53,000-acre 416 Fire.

The second prong of the AIM program, which separates it from other opportunities currently available, is its plan to provide guidance and mentorship, as needed.

"COCO is connected to many wildfire mitigation professionals through the Fire Adapted Communities Learning Network," said Jon Bruno, Chief Operating Officer for COCO. "Our plan is to connect recipients to some of these professionals through a mitigation mentorship program." This mentorship will be available from project/program design throughout the life of the project.

#### **Major Duties**

In 2012, the Grandfather Ranger District on the Pisgah National Forest began a project under the Collaborative Forest Landscape Restoration Program (CFLR). The Grandfather Restoration Project met the program's eight-year goal of treating 40,000 acres in 2017, with two years to spare. This funding has been extended and is anticipated for two more years. Project priorities are to restore fire-adapted vegetation; improve wildlife habitat through silvicultural treatment; treat non-native invasive species in high priority areas; to protect hemlocks from the hemlock woolly adelgid; and to benefit water quality and aquatic ecology.

This position has responsibilities for leading high priority, special projects with complex and numerous resource and protection considerations. A primary focus will be providing program management, facilitation, and internal and external communication for the Grandfather Ranger District's CFLR Project. The incumbent will be responsible for coordinating with a wide range of cooperators and partners to find and achieve common goals and accomplishments. This District has strong culture of working with federal, State and NGO partners to meet restoration objectives and enhance our communities. We are looking for an individual serve this culture of collaboration with strong communication and leadership abilities. Candidates are asked to reflect on their communication skills and abilities to maintain and develop new partnerships.

The duties are primarily in an office setting with periodic field work in support of resource analysis and implementation of management activities.

#### **Grandfather Ranger District**

The Grandfather Ranger District is part of the Pisgah National Forest and consists of approximately 195,000 acres across 5 counties. The District stretches from the McDowell/Buncombe County line just east of Asheville to US 321 between Lenoir and Blowing Rock. The Blue Ridge Parkway forms the northern boundary of the District and separates it from the Appalachian Ranger District.

Of interest on the District are the 12,000 acre Linville Gorge Wilderness; the Wilson Creek Wild and Scenic River and two wilderness study areas (Lost Cove and Harper Creek). There is also an extensive trail system that includes the Brown Mountain Off-Highway Vehicle Area.

The Grandfather Ranger District office is located beside Interstate 40 near Nebo, NC. Nebo is located in the foothills of the Blue Ridge Mountains with easy access to the mountainous sections of Western North Carolina. The northern and western part of the district is in mountainous terrain while the eastern and southern areas are mostly in the foothills. Elevations range from 900 to 5,665 feet above sea level. The District is predominately south facing, as such, has an active fire management program and prevalence of fire adapted forests.

A wide variety of recreational opportunities are provided locally, including: backpacking, fishing, hunting, cycling, mountain biking, rock climbing, and bird watching.
