News from the Field

Arkansas: The **Arkansas Prescribed Fire Council** hosted its **annual burn workshop** the last week of September. **Sixty-one students** from nine agencies took part, assisted by more than 50 instructors and support staff. California: *Biohabitats* has a good **interview with Frank Lake** (frank.lake@usda.gov) in its [fall equinox issue](#). Washington: The **Northeast Washington TREX** is coming to a close this week, after burning with the Colville National Forest and training with Joint Base Lewis-McChord fire staff, EcoStudies Institute and their partners. WTREX: The **Klamath Women-in-Fire TREX** (KWTREX) wrapped up a few days ago. Funding: AIM / Montana

AIM: Coalitions & Collaboratives, Inc. is seeking applicants for its **Action, Implementation & Mitigation grant program**, which is targeted at increasing communities' capacity to reduce wildfire risk and increase resiliency. There is a two-step application process: **concept papers** are **due by October 31**, and a subset of applicants will be invited to submit an online application. Montana: The **Montana DNRC** is requesting project proposals for **Montana Forest Action Plan Grants** that reduce wildfire risk and improve forest health on state, county, tribal, private lands, and federal lands through the Good Neighbor Authority. Feedback Requested: Smoke Grant Program / FireMap

Smoke Grant Program: The federal **Environmental Protection Agency** is **seeking feedback** for its upcoming Wildfire **Smoke Preparedness in Community Buildings** Grant Program. There is a **public listening session** on October 13, and the grant program will be on the agenda of an October 18 National Environmental Justice Community Engagement Call; comments can also be submitted by email by **November 2**. FireMap: The **SE FireMap project** maps all detectable fires across nine states in the southeastern U.S. The map and associated tools aim to improve fire management in urban and rural communities through **remote sensing** and track both prescribed fire and wildfires. Birds: The *Science You Can Use* [issue](#) “Birds & Burns: **Can Prescribed Fires Limit Wildfire Severity While Maintaining Fire’s Ecological Importance** to Bird Species?” captures highlights from a couple of recent papers documenting the effects of the 2007 East Zone Complex Fire in Idaho.

Grazing Fuel Breaks: The [article](#) “Using **Virtual Fencing** to Create Fuel Breaks in the **Sagebrush Steppe**” describes a successful experiment in using cattle to graze a linear fuel break. (Highlights are in a [media release](#) from Oregon State University.)

Performance Measures: The “Report on May 2022 Workshop on Outcome-Based Performance Measures” summarizes this Public Lands Policy Group project led by **Courtney Schultz**, highlighting

key issues and recommendations. This work is in response to “ongoing congressional and agency emphasis on designing ‘outcome-based’ performance measures to **track the implementation and efficacy of fuels reduction and forest restoration** treatments.” Find a link to the report in the right-hand column of the [policy group’s web page](#).

Governance: The [article](#) “Re-Envisioning Wildland Fire Governance: Addressing the **Transboundary, Uncertain, and Contested** Aspects of Wildfire” makes a distinction between cross-boundary and transboundary in describing wildfires, because of the differences in power, authority and capacity between parties.

Foresight: The [paper](#) “Strategic Foresight in Forestry: How Canada and the United States Use a Neglected Tool to Build a Green, Healthy and Resilient Future” introduces the **concept of strategic foresight** and **several methods** that can be used. “The essence of foresight is exploring a wide range of **alternative futures—possible, plausible and preferable**—rather than focusing on a single future.”

Rx Liability: California’s governor signed the **Prescribed Fire Claims Fund** ([SB926](#)) into law in late September, making prescribed fire a more accessible tool in the state. [Read more](#) in “**Empowering Private Landowners** to Prevent Wildfires” from the Stanford News Service.

Air Quality: The New York Times [article](#) “**Wildfire Smoke Is Erasing Progress** on Clean Air” is illustrated with maps showing changes over the last 15 years.

Indigenous Fire: An [op-ed](#) in the *Los Angeles Times* by **Don Hankins, Scott Stephens** and **Sara A. Clark**, “Why Forest Managers Need to Team up With Indigenous Fire Practitioners,” makes a clear **case for fundamentally changing the systems** we’ve built that exclude fire.

Smoke & Fungi: The Wired [story](#) “**Wildfire Smoke May Carry Deadly Fungi** Long Distances” concludes by noting that this may be another argument for **increasing prescribed burning**.
