



RESTORING AMERICA'S FORESTS

SOUTHERN BLUE RIDGE COOPERATIVE LANDSCAPE

ABOUT THIS PROJECT

The Southern Blue Ridge is one of the most biologically significant regions in the United States, boasting an **unbroken network of our country's most diverse forest** that spans and connects the mountains of Virginia, Tennessee, the Carolinas and Georgia. Yet **a third** of the national forest land in the region **needs active restoration**. The Nature Conservancy is participating in **several collaborative efforts** designed to increase the pace and scale of restoration.

OUR ACCOMPLISHMENTS

- ▶ Partners in the Southern Blue Ridge Fire Learning Network collectively achieved **49,000 acres of prescribed fire**, and managed 12,000 acres of wildfires with no homes lost.
- ▶ U.S. Forest Service support of \$300,000 enabled the Conservancy to hire **three seasonal crews** to assist with **partnership prescribed burns and other restoration** work in the Southern Blue Ridge and Central Appalachian landscapes, a very large step towards meeting our restoration goals.
- ▶ With Western Carolina University, Clemson University and the U.S. Forest Service, we are finalizing an analysis of six years of **fire monitoring data** from 12 sites in the SBR FLN.
- ▶ **Collaborative restoration efforts** are popping up everywhere in our region, including a new effort on the South Zone of the Cherokee National Forest, another on the Chattahoochee National Forest and a project in the heart of the Pisgah National Forest.

LOOKING AHEAD

We will continue our partnership with the U.S. Forest Service to create a **shared vision, goal and targets** for ecological restoration on federal lands. By enabling collaborative landscape-scale NEPA in priority places, we will work to facilitate NEPA for larger areas to **increase the efficiency** of the process and ultimately **implement more restoration** projects in priority areas.

SUPPORTING NATIONAL PRIORITIES

The Southern Blue Ridge project is supporting national efforts to double the pace of forest restoration by addressing:

- Improving restoration through **better forest planning** and **innovative NEPA tools**
- Enhanced partnership tools and emphasis to support federal **Collaborative Forest Landscape Restoration Program** projects
- **Outreach and training to facilitate restoration** for fire-adapted forests and communities
