## LANDFIRE Responds

Welcome to this new series where we communicate how LANDFIRE is responding to the changing needs of users.

**Challenge:** In the past, LF released disturbance data by GeoArea and had planned to follow that schedule with the LF 2023 disturbance release. Due to user feedback, we created a different plan for LF 2023's disturbance products. LF users needed

information on disturbance earlier in the year to provide enough time to support timesensitive updates such as risk management efforts and fire planning. This feedback informed our LF 2023 disturbance release plans.

**Solution:** Because of this feedback, in January 2024, LF released a new product called <u>Limited Disturbance (LDist)</u>. This product was created to provide a first cut of landscape change information including fires, disturbance events, and land management activities that occurred in (calendar year) 2023.

How will future climate change impact prescribed fire

Speaker: Dr. Alex Jonko, Staff Scientist, Earth and Environmental Science, Los Alamos Natl. Laboratory Dec. 4, 2024 1 pm (ET)

The use of prescribed fire to manage ecosystems is increasing across the United States, but climate change





threatens to impact future opportunities for prescribed fire as a result of changes in meteorological conditions and fuels. Dr. Jonko will discuss the results of a recent study which combined prescription information from 80 sites across the US with LANDFIRE fuels data and downscaled future climate projections to evaluate how climate change will impact future availability of burn days. Her results indicate that rising maximum temperatures may lead to decreases in burn days across the eastern US, while rising minimum temperatures and decreasing wind speeds may lead to increased opportunities for prescribed fire in the northern and northwestern US.
