News from the Field

Georgia: From the SBR FLN, the report "Using LiDAR to Analyze Vegetation Structure and Ecological Departure in the Upper Warwoman Watershed, Georgia" is now posted on the Conservation Gateway. The analysis, by Josh Kelly (josh@wnca.org), showed that five of the seven forest ecosystems in this part of the Chatahoochee NF are highly departed from reference conditions, indicating that fire management and other techniques that create disturbances would be ecologically beneficial here.

New Mexico: In the northern part of the state, the FLN is now casting a wider net, as a key partner in the **Rio Grande Water Fund**, which is working to protect the **watershed** that supplies **more than half the state's population**. You can read a little about the project on <u>nature.org</u>, or get more detail in the recently-released <u>comprehensive plan</u>.

North Carolina: A recent <u>blog post</u> on **wildlife monitoring** in the **Grandfather CFLRP** project includes photos of **bears**, **bobcats and more** using areas that have been treated with prescribed fire. This monitoring project will run through the fall, and is **testing the hypothesis** that wildlife use the treated units more than adjacent unburned areas.

Virginia: They're putting the interns to work in the Central Apps FLN this summer. A crew of four TNC LEAF interns spent four weeks in the Allegheny Highlands and Clinch Valley this summer. Among their tasks was the installation of recently-completed interpretive signage about prescribed burning, such as this sign at the Bear Loop burn unit at the Warm Springs Mountain Preserve.



National: Chris Topik, director of the Conservancy's Restoring America's Forests program, is one of 21 newly-appointed members of the **Forest Service**'s **Planning Rule Federal Advisory Committee** (FACA). According to the <u>press release</u>, "The recommendations provided by the FACA Committee are critical to the successful implementation of the Planning Rule."

Resources: Fire GIS Training / Firebreaks / USFS FAC / LANDFIRE

Fire GIS Training: A series of **National Park Service** <u>webinar recordings</u> cover topics from collection of **field data** to **finding GIS data** to step-by-step **development of a fire map**. The series is aimed at mapping for wildfire incidents, but much of the information may be **useful in other contexts** as well.

Firebreaks: Great Plains FLN partner Pheasants Forever has an <u>eight-page brochure</u> on firebreak management. It covers types of firebreaks and considerations for choosing location and dimensions, and installing breaks. For more information, contact Ben Wheeler (<u>ben.wheeler@nebraska.gov</u>).

USFS FAC: The **Forest Service** now has a <u>webpage</u> on **fire adapted to communities**, with links to a variety of resources (including an FAQ memo that answers a few key questions—including "What is a fire adapted community?"—and a brochure for professionals).

LANDFIRE: In collaboration with several **JFSP** consortia, LANDFIRE will be offering two **three-webinar series** this fall. In each series, examples will be drawn from the geography of the hosting consortium, but are otherwise applicable to all interested people. More information is on the <u>Conservation Gateway</u>, and the individual webinars are in the <u>listings below</u>.

Reports: Cost Drivers / Communities at Risk

Cost Drivers: Last month the Union of Concerned Scientists released the <u>report</u> "Playing with Fire: How Climate Change and Development Patterns Are Contributing to the Soaring Costs of Western Wildfires," which provides a reasonably concise overview of the issue.

Communities at Risk: The National Association of State Foresters FY2013 "Communities at Risk" brief (attached) reports that there are nearly 73,000 communities in the U.S. at risk from wildfire. Of those, they note that 6% have taken steps to reduce their risk—defined as having Firewise (or similar) recognition, enacted a mitigation/fire prevention ordinances, or completing high-priority fuel treatments or maintenance actions identified in their CWPP.

Articles: Oaks / Great Basin Rehab

Oaks: The latest <u>newsletter</u> from the Oak Woodlands & Forests Fire Consortium includes a brief article on herbicides as a fire surrogate for oak regeneration and a summary of (and link to) an article on reversing legacy effects in the understory, as well as listings of webinars and field tours.

Great Basin Rehab: A JFSP project (David Pyke and colleagues) looked at seeding **outcomes** under various conditions 8 to 21 years after **post-fire seeding**. The results (and management implications) can be found in the <u>final report</u> and in the <u>article</u> "**Long-Term Effects** of Seeding after Wildfire on Vegetation in Great Basin **Shrubland Ecosystems**" in the *Journal of Applied Ecology*.

Videos: Slide Fire / Rx Fire Uses

Slide Fire: The **Southwest Fire Science Consortium** has an 11-minute <u>video</u> on the management of the Slide Fire that burned in May between Flagstaff and Sedona, AZ. "**Every Fire is an Opportunity** to Treat a Landscape" discusses how the tactics chosen **lessened negative impacts** to the forest and watershed and supported firefighter safety, and how these **indirect tactics** are part of a **national trend**. The consortium has also posted a **virtual field tour** of the fire area using <u>Google maps</u>.

Prescribed Fire Uses: The Northwest Fire Science Consortium <u>video</u> "Prescribed Fire: A Multi-Purpose Tool" gives a couple of Washington state examples of the use of prescribed fire—to reduce hazardous fuels in east-side ponderosa pine forests, and for prairie restoration in the western part of the state (the latter described by Sarah Hamman).

Prescribed Fire Series: The Great Plains Fire Science Exchange has recently posted a <u>set of five videos</u> featuring John Weir (Oklahoma State University). Topics covered are the effects of burning in different seasons, controlling sericea lespedeza, consequences of not burning, controlling brush, and effects on grazing.

In the News: Fires Managed for Resource Benefit

Resource Benefit: An <u>article</u> in *Wildfire Today* covers the **Sitgreaves Complex** (near Flagstaff, AZ), where managers hope to treat **up to 19,000** acres of mostly ponderosa pine by managing a fire ignited by lightning on July 13. And on the **Santa Fe NF**—and falling within the **Rio Grande Water Fund**—the **Pino Fire**, first sighted on August 13, is being allowed to burn. According to the <u>Albuquerque Journal</u>, it is located in a unit that was slated for prescribed fire in the coming month.



The National Association of State Foresters continually surveys all states to determine progress in identifying communities at risk and developing Community Wildfire Protection Plans.

This report helps provide a national snapshot of wildland fire risk, preparedness and capacity. The FY 2013 data were collected through the U.S. Forest Service's National Fire Plan Operations & Reporting System, and reflects data accomplishments through September 30, 2013.

Background

State Foresters have made advances in the methods and information used to identify and assess communities at risk (CAR), which has led to the identification of 72,681 communities at risk. The number of CARs covered by a CWPP (17,060) shows an increase of 2,285 since last year's report, an increase of 15%.

Reduced Risk

A community is at reduced risk from wildland fire if it has satisfied at least one of the following requirements:

- 1. Recognized as a Firewise community or equivalent,
- 2. Enacted a mitigation/fire prevention ordinance, or
- 3. High priority hazardous fuels identified in a CWPP are reduced or appropriate fuel levels on such lands are maintained in accordance with plan schedule.

Community Wildfire Protection Plans

State Foresters collaborate with local communities and others to prepare CWPPs. The table below shows how many of those communities in need are now covered by a CWPP, as well as how many CAR are at reduced risk.

National Increases in Capacity

Many at risk communities reported increased local suppression capacity as evidenced by:

- 1. The increasing number of trained and/or certified fire fighters and crews, or
- 2. Upgraded or new fire suppression equipment obtained, or
- 3. Formation of a new volunteer fire department or expansion of an existing department.
