News from the Field

California: In northern California, where several large fires are burning, there's also some good news. A **prescribed burn** conducted by the Forest Service last fall **helped firefighters stop the Oregon Fire** at under 600 acres. See the <u>post in Wildfire Today</u> for the **remarkable image** of the prescribed fire and wildfire footprints—certainly a case of a picture that's worth a thousand words.

California: In **FireScape Monterey**, **sudden oak death** (SOD) is a threat to biodiversity, human communities, cultural resources and the aesthetic and spiritual values of the northern Santa Lucia Mountains. Hundreds of thousands of oaks in the area have died from the *Phytophthora ramorum* pathogen, creating **high fuel loads**, **changing forest composition** and **reducing acorn production**. Core team members from UC Davis and the Coastlands neighborhood near Big Sur recently coordinated the first phase of a privately-funded **SOD mitigation project**. They collected samples from 140 California bay laurels (a host for the pathogen) and sent them to a lab. They also removed about 150 symptomatic bay trees, and trimmed others to allow light and drying to limit the pathogen. The project **also improved access for fire control** in the neighborhood, creating adequate clearance for the Type 3 engines used by the local fire brigade.

Idaho / Montana: The Island Park Sustainable Fire Community wrapped up the summer with three days of touring and discussing treatments and issues in the FAC LN pilot communities of Island Park and West Yellowstone. For more, see the attached *Notes from the Field*.

Washington: With wildfire in their backyard this summer, the FAC LN hub Chumstick Wildfire Stewardship Coalition developed a nice reference for adding FAC concepts to existing wildfire messaging. The brief table lists likely messages, along with "one more sentence" that can be added to align the outreach with the 2014 National Fire Season Theme #4: "A community that has adapted to wildfire is a better-protected community." An <u>introduction letter</u> for public information officers and the <u>suggested messages</u> are posted on the NIFC PIO bulletin board, and the messaging is being shared by the Western Region Strategy Committee. WUI Mitigation Guide: The National Wildfire Coordinating Group (NWCG) has just released a Wildland Urban Interface Wildfire Mitigation Desk Reference Guide. The <u>27-page guide</u> is intended to help integrate WUI principles into national wildland fire training; promote a common, consistent language for wildfire mitigation; and establish an authoritative source for WUI mitigation information.

Working Woodlands: *National Woodlands* is a publication of the National Woodland Owners Association. The <u>summer 2014 issue</u> focuses on wildfire, mainly from the **perspective of privately-owned working woodlands**.

Juniper Fuel Moisture: The Great Plains Fire Science Exchange has a <u>new fact sheet</u> on "Determining Live Fuel Moisture in Junipers." It includes **step-by-step instructions** for determining and interpreting fuel moisture.

Equipment Sharing: Iowa State University has produced a <u>guidebook</u> for small farmers that may have applicability to groups considering sharing other types of equipment. The *Machinery Sharing Manual* for *Fruit and Vegetable Growers* includes sections on choosing suitable partners, agreements, joint ownership and other **operational and organizational issues** to consider.

Notes from the Field

Community Field Trip Provides Opportunity for Shared Learning Island Park Sustainable Fire Community

The Island Park Sustainable Fire Community is a FAC Learning Network hub that works in an area extending from Island Park, just north of Ashton, Idaho, into West Yellowstone, Montana. Island Park is also a Western Cohesive Strategy pilot project. Targhee National Forest land surrounds much of the town of Island Park and its unincorporated neighborhoods. Few homeowners live in Island Park year-round, and many only visit their homes for a handful of weekends each summer.

As the summer came to a close, the collaborative hosted a series of field trips designed to update members on recent accomplishments and to facilitate discussion about a number of issues.

On the first day, the group visited the Yale Creek, Palmer Summer Homes and Stonegate neighborhoods, where landowners have created defensible space in the home ignition zone. The collaborative provided funding for four of these demonstration sites in 2014, and each treated property has a sign indicating that it is a "Sustainable Fire Property." In addition, the collaborative hired two outreach coordinators to go door-to-door in the Yale Creek and Stonegate neighborhoods and have conversations with homeowners about wildfire risk. Their interviews indicate that the sustainable fire property signs are getting noticed

and that neighbors are talking with one another about fire. Although there are some residents who oppose tree removal, many others are interested in mitigation.

The next morning, the collaborative convened its monthly meeting and then the group visited some fuels treatments in and around West Yellowstone. Montana. close to the boundary between the Targhee and Gallatin National Forests. Forest Service staff from the two forests coordinate their work closely and have taken steps to ensure their fire plans are similar. (Due to the prevailing winds, wildfires on the Targhee can and do threaten homes and other values in Montana.) Gallatin National Forest staff also coordinate closely with the West Yellowstone Fire Department, conducting joint fuel reduction projects in wildlandurban interface areas.

And on the following day, the group visited an aspen restoration project near Henry's Lake, Idaho and a proposed fuels reduction project adjacent to the Yale Creek neighborhood. Discussions touched on litigation, the challenges associated with getting homeowners to accept prescribed fire as a restoration and fuels reduction tool, conifer encroachment into aspen, Douglas fir regeneration and options for improving ingress/ egress for Yale Park residents.
