#### News from the Field

**California**: **FireScape Mendocino** held the **fourth workshop** in its Open Standards planning series a couple of weeks ago. More about their progress is in the attached *Notes from the Field*.

**California**: **Don Amador**, a partner in the **FireScape Monterey** landscape, has a <u>blog entry</u> on the value of **shaded fire breaks** on his *Quiet Warrior Racing* blog. Don brings the concerns and expertise of the off-highway vehicle community to that partnership.

California: Nick Goulette's FAC Learning Network <u>blog entry</u> "It Takes All Three to Protect a Community" is a first-person account of the Oregon Fire and its successful management. "The real story is that only through the timely and effective implementation of all three National Cohesive Wildfire Strategy goals in combination, was the community spared far worse consequences."

**Colorado**: **FAC Learning Network** hub organization **Coalition for the Upper South Platte** has been named a **Community Preparedness Hero** by **FEMA**. Eleven people and groups <u>were awarded</u> one of the agency's individual and community preparedness awards, from among the 230+ applications submitted. National: The Nature Conservancy, Forest Service and Department of the Interior have signed a new five-year cooperative agreement, Promoting Ecosystem Resilience and Fire Adapted Communities Together: Collaborative Engagement, Collective Action and Co-ownership of Fire. The PERFACT agreement is the latest in the series of agreements that since 2002 have supported the Fire Learning Network, training, outreach, and now the Fire Adapted Communities Learning Network and Scaling-up to Promote Ecosystem Resiliency (SPER) implementation projects. Thanks to all who are, and have been, a part of this work—and we're all looking forward to more progress in the years ahead.

#### Articles & Reports: Oaks / WUI Communities / GHG Mitigation

Oaks: The Northern Research Station has released the report "The Fire-Oak Literature of Eastern North America: Synthesis and Guidelines" (Brose, Dey and Waldrop). The report is the product of a JFSP project to "develop guidelines for using prescribed fire to restore and sustain upland oak ecosystems in eastern North America."

WUI Communities: The concept of "wildland-urban interface" is broad. The working paper "Community Diversity and Wildfire Risk: An Archetype Approach to Understanding Local Capacity to Plan for, Respond to, and Recover from Wildfires" addresses the questions: Are there patterns of influences on wildfire risk management that can be documented across case studies? and Do communities exhibiting similar patterns constitute distinct "archetypes" that approach wildfire risk differently from others?

Greenhouse Gas Mitigation: From Australia, the effects of a fuel reduction burn on a wildfire that followed three months later are reported in "Fuel Reduction Burning Mitigates Wildfire Effects on Forest Carbon and Greenhouse Gas Emission" in the International Journal of Wildland Fire (abstract).

## Fire Learning Network Notes from the Field

## FireScape Mendocino Workshop 4

Willits, California

September 3-4, 2014

**Forty-one people** gathered for the fourth workshop in FireScape Mendocino's Open Standards for the Practice of Conservation planning series. The objectives of this workshop were to:

- review and refine the consolidated situation diagram;
- based on the prior threats analysis, identify six or fewer strategies that could realistically abate those threats:
- examine, through map work and case studies, how strategies could be put on the ground;
- discuss the complexities involved with NEPA and large-scale projects: and
- gauge which strategies FireScape Mendocino participants have the capacity to undertake in the next three years.

Two days of focused work resulted in excellent progress, starting with a shared understanding of what each stakeholder hopes to accomplish through FireScape Mendocino. This includes the Forest Supervisor's vision for forest-wide projects, including a forest-wide NEPA analysis for vegetation treatment, and increased understanding of the Supervisor's vision by Mendocino NF staff. A great new technique, based on Google Earth, was used for developing scenarios. Set of nested targets for

the "Terrestrial species, structure and function" target and "Riparian and aquatic habitat, species and function" were also drafted.

The revised values are still evolving, but they currently are:

- · Fire-adapted human communities
- Cultural heritage: past, present and future
- Landscape-based economic opportunities
- Outdoor recreation opportunities
- Riparian and aquatic habitat, species and function
  - Native fish
- Terrestrial species, structure and function
  - · Late successional conifer forest
  - · Oak woodlands
  - Serpentine and meadows.

Perhaps most important was the conclusion by the group that this collaboration belongs to all participants, rather than just to the Forest Service.

Next up for this landscape is an after action review (AAR) for the workshop, which will be conducted by the core team via conference call. There will also be follow-up with newcomers to the group, and thank-you letters to send. Looking ahead, a small group will work on revising the situation diagram and producing updated results chains, and examine the products generated in the Google Earth exercise. These will feed into the work if the next workshop, which is expected to be in January 2015.

# Fire Adapted Communities Learning Network Program Assistant Job Announcement

#### **Background**

People and nature are increasingly threatened by fire, despite fire's natural, beneficial role. At the same time, firefighting costs are escalating and diverting money away from proactive land management. The solution is to make natural areas and communities more fire-adapted so that we can allow fire to play its natural role at a meaningful scale. The Fire Adapted Communities (FAC) initiative and the FAC Learning Network (FAC Network) are helping homeowners, communities and land managers in fire-prone areas prepare for inevitable fires -- to "live with fire" safely.

The FAC Network encourages the development and sharing of best practices and innovations in order to accelerate the adoption of fire adapted community concepts nationwide. The Network currently supports eighteen hub organizations who work with pilot communities that have committed to implementing, assessing and sharing the work that they are doing to increase their communities' resilience to wildfire. Funding is provided by the USDA Forest Service's Fire Adapted Communities Program (and participants' matching funds), and the Network is managed by the <u>Watershed Research and Training Center</u> and <u>The Nature Conservancy</u>.

#### **Job Summary**

The FAC Network is seeking a half time Program Assistant to work with the Network's <u>Coordinating Team</u>. The Program Assistant will be an employee of The Watershed Center, a non-profit organization based in Hayfork, CA. The FAC Network is a national program, and staff will not be required to live in Hayfork. However, remote staff must have access to high speed internet and phone line and be able to travel approximately 2-3 times per year.

#### The Program Assistant will:

- Lead the FAC Network's meeting logistics including organizing and logistics for an annual meeting with ~80 people, and other meetings and Network convenings as required
- Moderate and manage FAC Network's online workspace (Podio) including daily record keeping and storage of material and conversations with participants
- Assist the FAC Net Coordinating Team with scheduling, take and distribute notes of bi-monthly calls
- Act as the FAC Net "librarian" maintaining Network files and records in an organized digital format

The Santa Fe National Forest Headquarters will soon be advertising a term vacancy for a GS-0101/0401-11 Partnership Coordinator. The successful applicant will build advocacy for the restoration of Southwestern fire-adapted forest ecosystems by developing strong partnerships with the public, organizations, and other agencies. The incumbent will play a key role in the planning and implementation of the Southwest Jemez Mountains Collaborative Forest Landscape Restoration Program (CFLRP).

This position will be dedicated to the Southwest Jemez Mountains Collaborative Forest Restoration Project, located in the Jemez Ranger District on the west side of the Forest within the Jemez Mountains of New Mexico. Recreational and cultural experiences branch out in all directions, and you don't have to go far to find the ruins and petroglyphs from ancient Native American civilizations and incredible scenic features as you travel through colorful, volcanic formations, deep river gorges, and beautiful pine, fir, spruce and aspen forests. In 2005, Santa Fe became the first U.S. city to be chosen by UNESCO as a Creative City, one of only nine cities in the world to hold this designation. With a population of 70,000 people, it is small enough to feel homey, yet large enough to offer big-city amenities like public transportation, restaurants, shopping, and night life. With the national forest and other public lands close by, Santa Fe offers all kinds of outdoor recreation: biking, hiking, skiing, fishing, camping, rafting, OHVs, and horseback riding to name a few. Santa Fe averages 300 days of sunshine a year with mild summer days in the 80s and cool nights in the 50s. Winters are relatively short and cold, with snow accumulations primarily in the surrounding mountains. The average annual rainfall is 14 inches, and annual snowfall is 17 inches. The median price of homes sold from January through March of 2012 was \$259,2500.

#### **About Jemez Springs**

The Village of Jemez Springs is one of New Mexico's most enchanting destinations. Nestled between stunning red rock mesas--remnants of ancient lava flows over a million years old--the village is named for its famous mineral <a href="https://example.com/hot-springs">hot springs</a>.
