### News from the Field

California: The first of three back-to-back Prescribed Fire Training Exchanges, the Klamath River TREX, wrapped up last week. In just under two weeks, 90 participants made up three burn teams, and conducted 400 acres of controlled burning across 20 burn units. The Mid Klamath Watershed Council and Karuk Tribe led this complex event, using a unified command approach with a Type III Incident Management Team. Together they successfully organized burns across many different ownerships and coordinated air quality and burn permits during times when burning is severely restricted and air quality is hampered by poor dispersion. The efforts support the local goal of protecting communities so that fire can be allowed to regain its natural role on the landscape. Read more about the event in the excellent article by Malcolm Terence ("Fall Burn for Neighborhood that is No Stranger to Fire") that's just been posted by the Siskiyou Daily News. There are also several informal videos from the event on the KlamathMedia YouTube channel, including a brief interview with local participant Heather Rickard, talking about why she came back for her second TREX.

The second training exchange—the **Yurok TREX**, based in Weitchpec—began **yesterday**, and the **Northern California TREX** is scheduled to start **next week**.

**Colorado**: The **Pikes Peak FLN** is planning some **prescribed burning** this fall. Updates on the proposed burns—and other network activity—are on their **new website** (<a href="http://www.pikespeakfln.org/">http://www.pikespeakfln.org/</a>). They are also now on **Twitter**, at <a href="https://twitter.com/pikespeakfln.org/">https://twitter.com/pikespeakfln.org/</a>).

**Minnesota**: In the newspaper article "Eagles Nest **Chipper Day a Big Success**" (attached), local **FAC Learning Network** coordinator **Gloria Erickson** noted that community members "did an amazing job. One day turned into a four-day chipping event." The network hosted **three events** in the Ely area this summer, with about **85 people** taking advantage of the opportunities.

**New Mexico**: The **Spanish-language TREX** wrapped up last week after two weeks, with **25 participants** completing **987 acres** of burning, including almost 800 acres in a high-priority unit in the **Santa Fe municipal watershed**. A <u>story on KSFR radio</u> covered the TREX, and highlighted women in the fire management field.

Washington: Reese Lolley (<u>rlolley@tnc.org</u>) provided background for, and is among those quoted in, the in-depth Seattle Times <u>article</u>, "Fighting Fire with Fire: State Policy Hampers Use of Controlled Burns." The article notes that over the last 13 years, the Forest Service has conducted controlled burns on 4.7 percent of its forests in Oregon, but only 1.4 percent in Washington.

**Washington**: Development of the **state-wide Fire Adapted Communities Learning Network** is well under way—the South Central Washington RC&D is **seeking a coordinator** who will support the work of both the FAC Net and prescribed fire council (see Jobs listings, below, or the attached position announcement).

# Resources and Articles: Citizen Science / Ecology and Society

Citizen Science: The president's Office of Science and Technology has issued a <u>memorandum</u> on "Addressing Societal and Scientific Challenges through Citizen Science and Crowdsourcing" to federal department and agency heads. The memo includes some basic principles to follow, as well as examples of how this more inclusive data gathering and science is being successfully applied.

Among the other articles in the issue is "**Re-envisioning Community-Wildfire Relations** in the U.S. West as Adaptive Governance" (Jesse Abrams et al.).

# Compositional and Structural Changes over Time with Different Fire Regimes in Linville Gorge, NC

11:00 Pacific / noon Mountain / 1:00 Central / 2:00 Eastern (1.5 hours) In this **Southern Blue Ridge FLN** webinar (originally scheduled for August 18), **Cassandra Pallai** will discuss research conducted in Linville Gorge based on resampling plots originally put in during 1992 for her Master's project at Duke University. The plots have been resampled (by Waldrop and others) periodically and give a nice sampling of different fire regimes in Linville. Plots within the Table Rock Fire footprint were recently sampled, and Pallai combined those results with the original sampling and Waldrop's resampling to study compositional and structural changes over time with different fire regimes. # Eagles Nest chipper day a big success

EAGLES NEST - Crews from Evergreen Construction Co. chipped trees and branches along Peninsula and Trygg roads in Eagles Nest Township last week as part of a Chipper Day event sponsored by Fire Adapted Communities.

Residents in that neighborhood did their part to improve the fire safety and defensible space on their properties. They learned first-hand this summer how to make their own property more survivable from wild fire at a series of demonstrations sponsored by the local chapter of Fire Adapted Communities.

Gloria Erickson, the local coordinator for the Fire Adapted Communities organization, is continuing her efforts to make all Elyarea residents aware of the very real danger of wildfires for those living in northern Minnesota. As many as 85 people participated in three workshops.

As part of that workshop, landowners had the opportunity to trim their properties and have the trees and branches chipped right at their property line along the road.

Erickson said she was amazed at the involvement of the property owners. "These folks did an amazing job," she said. "One day turned into a four-day chipping event."

She related how neighbors helped neighbors to get the job done. "We saw THE 'older' or 'over-

60' crowd out there cutting and hauling a phenomenal amount of fuel to be chipped, she said. "These are amazing people, neighbor helping neighbors who may have a tough time walking, all chipping in to help each other. It's been amazing."

Larry Anderson hosted a workshop with local fire department officials, U.S. Forest Service personnel, even a fire truck, at his home in Eagles Nest Township. Similar workshops were held this summer at the homes of Phil and Jan Hogan on Pine Tree Trail and Paul and Susan Schurke on Ring Rock Road.

As part of the demonstrations, Firewise evaluators signed up other land owners for a free Firewise Home Evaluation.

Erickson is also work on determining additional dates for future demonstrations and additional Chipper Days.
