News from the Field

California: Elizabeth Azzuz and Bill Tripp—and the Indigenous Peoples Burning Network and TREX—are front and center in the excellent *High Country News* article "The Fire We Need."

Washington: The Washington Prescribed Fire Council has posted a good meaty <u>summary</u> of its 2020 annual meeting. It includes updates on TREX and work on the state's Certified Prescribed Burner Program (with a link to the <u>report</u> that the Forest Stewards Guild produced with the Washington RC&D), as well as highlights from a presentation by Lenya Quinn-Davidson about the spread of prescribed burn associations in California. DEI: Twenty-five network members and colleagues participated in last month's **Active Bystander**, **Active Self workshop**, one of a series of four **virtual workshops** on topics related to **diversity**, **equity and inclusion**. Feedback indicated that adapting the material to a virtual format (via videoconference) worked well, with a mix of presentation, breakout sessions and whole-group discussions.

FAC Net: In a wonderful **Wildland Fire Lessons Learned Center** <u>blog post</u> "A Conversation with **Annie Schmidt** of the Fire Adapted Communities Learning Network," Annie talks about FAC Net and how investments in resilience and learning are critical to success. (Remember the Great Bus Crisis of 2018, and the amazing resilience demonstration? Annie does.)

Resources: Wildfire Risk / NWCG Courses / Remote Collaboration / Mental Health

Wildfire Risk: The Forest Service Wildfire Risk to Communities website has interactive maps, charts and resources to help communities throughout the U.S. understand, explore and reduce their wildfire risk.

NWCG Courses: The **National Wildfire Coordinating Group** has posted <u>guidance</u> on **virtual delivery** of courses.

Remote Collaboration: Sustainable Northwest has produced the guide "Resources and Best Practices for Adjusting to Remote Collaboration." Intended for collaboratives in Oregon and Washington, much of the advice (such as platforms and best practices for connecting virtually) is widely applicable. It also includes an appendix on the Coronavirus Aid, Relief, and Economic Security (CARES) Act, calling out provisions for small businesses and private nonprofits.

Mental Health: Experts warn that we can expect a wave of mental health problems associated with the coronavirus crisis (and, indeed, that it has already begun). Among the resources that colleagues have recommended are the guide "Living With Worry and Anxiety Amidst Global Uncertainty" (from psychologytools.com, in 20 languages) and a FACE COVID mnemonic for practical steps based on the principles of acceptance and commitment therapy.

Articles & Reports: Southern Apps / CWPPs / Forests & GHG / Soils / Fire Effects

Southern Apps: In response to the severe **fire season of 2016**, the **Southern Research Station** produced the <u>general technical report</u> "Fire in the Southern Appalachians: Understanding Impacts, Interventions, and Future Fire Events." The report delves deeply into **prescribed fire laws**, **regulations and recent history** in the region.

CWPPs: The **Ecological Restoration Institute** has released an "**Assessment** of Community Wildfire Protection Plans (CWPP) in Arizona and Throughout the West." The <u>report</u>—based on document review, surveys, interviews and focus groups—provides "**lessons learned and recommendations** that may help to shift the development and implementation of CWPPs **toward more focused and strategic implementation** designed for each plan's unique local context."

Forests & GHG: The Forest Service has released the <u>brief report</u> "Greenhouse Gas Emissions and Removals from Forest Land, Woodlands, and Urban Trees in the United States, 1990-2018." An <u>appendix</u> to the report provides detailed data by state, year and carbon pool (e.g. aboveground biomass, mineral soil, harvested wood, etc.).

Soils: The **Ecological Restoration Institute** and **Southwest Fire Science Consortium** have released the <u>report</u> "Fire and Soils in Frequent-Fire Landscapes of the **Southwest**." The report includes a section on how fire affects **forest soils**—including burning **duff**, **erosion** and loss of **nutrients**—and **how to consider soils** when planning treatments.

Fire Effects: The authors of the <u>article</u> "Ecosystem Management Applications of Resource Objective Wildfires in Forests of the Grand Canyon National Park, USA" assessed **forest structure and composition** a **dozen years after wildfire** at three sites that contained permanent monitoring plots. For a quick **overview** of the paper, see the <u>fact sheet</u> from the **Ecological Restoration Institute**.

Requests: Tick Survey / COVID-19 Lessons

Tick Survey: Researchers at the **University of Georgia**, **Hollins University**, **Duke University**, **Clemson University** and the **University of Rhode Island** are **conducting a study** ("Investigating COVID-19 impacts on the epidemiology of tick-borne diseases in people and pets") to determine whether **COVID-19 restrictions** have had an effect on the **time spent outdoors** by people or their pets and whether this change is associated with an increased risk of exposure to ticks or **tick-borne diseases**. Anyone 18 or older and a resident of the United States or Canada can <u>participate</u>.

COVID-19 Lessons: The **Wildland Fire Lessons Learned Center** is asking practitioners to **share things you've learned** about safe fire management during the coronavirus pandemic. With their Rapid Lesson Sharing, you <u>send them your lessons</u>, they polish and format, have you review, and then post the product for thousands to learn from. (You can also <u>ask to join</u> their **discussion forum** "COVID-19 and Fire Season 2020.")

Blogs: Wildfire as Metaphor / A Long Monday
