News from the Field

New Mexico: In late January partners in the Greater Santa Fe Fireshed Coalition landscape conducted pile burns on private lands in the WUI. The burns were covered, in the context of the regional drought, on two local TV stations (KOB4 and KRQU News 13). One squad member who was interviewed discussed his arc from youth corps experience to being on the crew through a capacity-building effort the Forest Stewards Guild, but that segment did not make it into the final story. Virginia: The article "Identifying Coarse- and Fine-Scale Drivers of Avian Abundance Following Prescribed Fires" will be published in the April issue of Forest Ecology and Management (abstract). Authors Dana Morin, Laurel Schablein, Nikole Simmons, Jean Lorber and Marek Smith based the article on the avian and forest structure monitoring efforts that have been conducted at the Warm Springs Mountain Restoration Project in the Heart of the Appalachians FLN landscape since 2009. Southern Blue Ridge: Hot off the virtual presses is "The Fire Manager's Guide to Blue Ridge Ecozones" by FLN landscape lead Adam Warwick (awarwick@tnc.org). After an introduction to fire in the mountains, the guide covers ecozones that need fire to sustain their flora and fauna, with detail on several plant species in each. A print version will be available soon.

IPBN: "Forever Forests: The Indigenous Peoples Burning Network in Action" appeared in a recent newsletter from The Nature Conservancy.

Resources: Home Retrofitting / CWPPs / Smoke / State Plans / Erosion

Home Retrofitting: The Tahoe Network of Fire Adapted Communities has released "Wildfire Home Retrofit Guide: How to Harden Homes Against Wildfire," with sections on everything from defensible space to chimneys. In addition to the excellent guide, the Tahoe Network has recordings of the three virtual workshops—one each for the public, building professionals and fire professionals and educators—that it hosted last year.

CWPPs: The **FAC Net** <u>blog post</u> "Re-Visiting Community Wildfire Protection Plans" summarizes the **lessons learned**—and **resources** found useful—by a learning group of **FAC Net members** that met regularly over the course of 2020.

Smoke: The "**Smoke Management Guidebook** for Prescribed Burning in the Southern Region" was created through a collaboration between the EPA, North Carolina State University, Southern Fire Exchange, Southern Regional Extension Forestry and the University of Georgia Warnell School of Forestry and Natural Resources. The <u>guidebook</u> provides a **good introduction** to smoke management for private (non-NWCG) burners, and a good **refresher for more experienced practitioners**.

State Plans: The **National Association of State Foresters** has an <u>index page</u> for **forest action plans** from all U.S. states and territories. It provides a brief **overview of each** state's plan with links to the plans and supporting resources.

Erosion: The **Ecological Restoration Institute** and **Southwest Fire Science Exchange** have released a new <u>working paper</u>, "**Mitigating Postfire Runoff and Erosion** in the Southwest using Hillslope and Channel Treatments." The paper includes sections on **assessments** to inform treatments, **hillslope erosion** treatments and **channel erosion** treatments (with tables comparing various options).

Articles & Reports: Treatments & Drought / Carbon Sequestration / Rx Use / Future Estrangement

Treatments & Drought: The authors of the <u>article</u> "Variable Thinning and Prescribed Fire Influence Tree Mortality and Growth During and After a Severe Drought" explored the effects of these treatments on forests in the central and southern Sierra Nevada.

Carbon Sequestration: The <u>latest Science Findings</u> from the Pacific Northwest Research Station, "Planting Trees to Mitigate Climate Change: Policy Incentives Could Lead to Increased Carbon Sequestration," shares the results of modeling several scenarios, including their economic impacts.

Rx Use: The <u>2020 edition</u> of the "National Prescribed Fire Use Report" has been released by the National Association of State Foresters and the Coalition of Prescribed Fire Councils. This report is now being produced annually.

Future Estrangement: In the <u>article</u> "Future Estrangement: **Not Having a Place in the Emerging Future**," David Bengston (Northern Research Station) notes that three large forces—technological change, economic globalization and climate change—are driving rapid change and, for many, "shaking our very belief in a viable future." In response, "a key line of attack is to **strengthen individual and societal resilience**"—through a system that incorporates diversity, modularity and tight feedbacks among its parts.

Tri County Fire Safe Working Group (TCFSWG) is a non-profit organization dedicated to wildland fire mitigation planning, population protection, outreach and education with respect to living with wildfire, and management of meaningful projects to sustain forest health and natural aesthetics in wildland/urban interface (WUI) settings of Lewis and Clark, Jefferson and Broadwater counties near Helena, MT.

Title: FireSafe Helena Program Manager

Supervisor: TCFSWG Executive Director

General Job Description: FireSafe Helena (FSH) is a FEMA funded project managed by TCFSWG. The program is structured to motivate and support property owners in reducing their risks from wildfire around the home ignition zone. The program manager provides program administration, outreach & education and coordination and oversight of cost-share mitigation activities.

Major Duties and Responsibilities:

- **Program Administration:** Manage the FireSafe Helena program to meet goals and objectives as outlined in the work plan and in compliance with FEMA grant guidelines and reporting requirements.
 - o Compile and maintain project records supporting eligible activities and costs.
 - Utilize management tools to implement and access program guidelines, criteria, and processes.
 - o Develop program monitoring programs and evaluation tactics to adapt program as needed.
 - Plan and coordinate community mitigation events that enhance private property mitigation projects.
 - Supervise conservation intern and potential volunteers. * see task list below.
- Assessments & Project Mitigation: Utilize existing and emerging technologies to identify site specific risks and wildfire risk reduction recommendations to homeowners.
 - Develop project design criteria and specifications.
 - Coordinate home ignition zone assessments, cost-share applications, project agreements, and reimbursement as well as project implementation and post-project monitoring.
 - Perform or supervise project inspections and contractor compliance to ensure adherence to design criteria and specifications for final project checkoffs.
 - Coordinate community mitigation special events (ie Chipper Days).
- Outreach & Education: Engage with WUI community members and leaders to increase awareness and
 understanding related to wildfire risk and mitigation activities that can be taken to reduce/mitigate risk.
 Coordinate and complete targeted outreach via a variety of mechanisms.

Minor Duties and Responsibilities:

- Maintain a complete understanding of all applicable FEMA policies, requirements, and evaluating protocols.
- Coordinate and help facilitate community, HOA and other related meetings and outreach opportunities to promote mitigation programs and strengthen program partnerships.
- Logistics and event planning.

Qualifications for the job:

- College degree in a related field and 1 year of experience in wildfire suppression or mitigation programs.
- Understanding and experience with a variety of topics/disciplines including:
 - Wildfire ecology in fire prone environments
 - Defensible space design, and mitigation best practices
 - o Structural ignition vulnerability and mitigation measures

Essential functions and key competencies of the position include, but are not limited to:

- Independent and self-motivated with ability to work remotely with limited supervision.
- Understand and effectively speak to wildfire related issues to deliver consistent yet site specific, engaging and science-based information and training about wildfire risk and mitigation best practices in both the built and natural environments.
- Analyze structure ignition potential in the wildland/urban interface using a science-based approach.
- Identify appropriate construction materials, material ratings, and techniques for the wildland/urban interface.
- Ability to simultaneously manage multiple projects and activities.
- Conduct reporting efforts by tracking detailed programmatic information using spreadsheets, written reports, photographs, and GPS/GIS technologies.
- Strong proficiency with word processing, spreadsheets, database management, social media and webpage.
- Ability and willingness to use a personal vehicle for travel within work areas. Mileage will be reimbursed.

Environmental & Physical Factors

Work is performed in an office, vehicle and/or outdoor setting in all possible weather conditions. While
performing the duties of this job the contractor is required to stand, sit, walk, talk or hear for extended
periods of time. Frequently walks over uneven-rough terrain, carries necessary job equipment.
Frequently sits in one position while driving.
